

WORLD CUP APPLICATION FORM
SANCTIONING PROCESS

World Cup Application forms must be completed in full and submitted to IPC Shooting Office at ipcshooting@paralympic.org no later than 12 months prior to the commencement of the competition.
Applications submitted outside the given timelines or are not completed in full will not be accepted.
Prior to any decision made a site visit by IPC Shooting must be conducted on the Local Organizing Committee cost.
IPC Shooting will announce its decision to approve the competition officially in writing.
If sanctioned a 400€ fee must be submitted by the LOC to IPC account and the LOC will be invoiced by IPC Shooting.
The sanctioning will be valid upon sign off of the Memorandum of Understanding (MOU), Doping Control Agreement (DCA) and payment of the sanctioning fee.
All World Cups will appear in the IPC Shooting Calendar.

AREA	MINIMUM REQUIREMENTS
Endorsement	If the competition is organized by a different LOC and not by the NPC the application must be endorsed by the respective NPC. The respective field in this application must be filled out.
Rules	The competition will be held according to current IPC Shooting Rules.
Programme of Events	The programme of events can be (the events in the parenthesis are optional): <ul style="list-style-type: none"> • Programme 1: R1-R8, P1-P4, (Falling targets) • Programme 2: R1-R5, P1-P2, (P5) • Programme 3: R6-R8, P3-P4 In case the World Cup is a Paralympic Qualifier then the Programme of Events is a Programme 1: R1-R8 and P1-P4 only
Finals	Finals are required for all the events in all Programmes.
Time Schedule	The IPC Shooting standardized schedule that is provided attached for the different Programmes must be followed. Any adjustments must be first discussed with IPC Shooting.
Minimum days of Competition	<ul style="list-style-type: none"> • For Programme 1: Five (5) days • For Programme 2: Three (3) days • For Programme 3: Two (2) days
Number of days for International Classification and Equipment Control	Two (2) days are required prior to the competition days.
Equipment	<ul style="list-style-type: none"> • Electronic Targets mandatory for finals • Set for SH1 and SH2 class equipment control. If those are not available it must be communicated to IPC Shooting • Other requirements like firing points, ranges specifications, etc must follow the ISSF rules for World Cups
Information Package	The information package that the LOC will use to invite the countries must be as per the IPC Shooting template.
Entries	All Athletes is required to be licensed and hold an active IPC Shooting license by the entries deadline.
	The minimum number of entries per event is four (4). Otherwise the event is not considered viable and will be cancelled.
	The athlete's final entries must be sent to IPC Shooting office the day after the final entries deadline and not later than 4-6 weeks prior the start of the competition. The athlete's SDMS ID number, international sport class and sport class status (if available) must be included in this list.

Technical Officials	The competition must be officiated by recognized ISSF and IPC Shooting referees.		
	Technical Delegate: A Technical Delegate outside the Host Country will be appointed by IPC Shooting. (For programmes: 1, 2, 3) Chief Referee: A Chief Referee outside the Host Country will be appointed by IPC Shooting. (For programmes: 1, 2, 3) International Referee: An International Referee outside the Host Country will be appointed by IPC Shooting. (For programme: 1,2,3) National Referees: will be selected by the LOC

Classification panel	The International classification panel will consist of two (2) International Classifiers and will be appointed by IPC Shooting. For protest opportunities 2 panels of two (2) International Classifiers each must be appointed as per the IPC Classification Code.		
Results	The LOC must submit the results from all events to IPC Shooting in the electronic version of IPC Shooting no later than 7 days after the end of the competition on the standardized template submitted by IPC Shooting		
	Results recognition will follow the IPC Processes for rankings and records lists		
Records	World record applications will be accepted only if Doping Control and international classification is conducted.		
	All World and Regional records claimed must follow the process of approval described in the IPC Shooting Rulebook.
